Natalie, who has her law degree, works for The Salvation Army as Director of Gift Planning. She described ways of giving to help those in our community. She represents the Intermountain Division, which serves people in Colorado, Wyoming, Montana, and Utah. She indicated that there are many ways to make our gifts: revocable and irrevocable. A will is a revocable gift. It is important for us to prepare a will with the help of our tax and financial advisors as the laws change frequently. We can change or revoke the will; it becomes very important document at death. Irrevocable gifts cannot be changed once implemented. An example is a Life Income Gift. They provide an income stream for individuals and their families while lending invaluable support to The Salvation Army. These gifts come in three types: charitable remainder trusts, charitable remainder unitrusts, and charitable gift annuities. 2020 International Kiwanis Convention Details

More than ever, leadership matters. That's why the 2020 Kiwanis International Convention will include multiple tracks for leadership training. In fact, you can tailor your convention experience to your own interests. Check out your options — from the education-only option to the full convention experience. Find what works for you. Then join us in Indianapolis!

Did you know clubs can pay all or a portion of each member's expenses for the Kiwanis Education Conference — part of the Kiwanis International convention — from its service account? The Kiwanis Education Conference qualifies as an acceptable educational expense of the club. Covered expenses can include: Registration fees up to US\$299, hotel, airfare or mileage, meals, per diem and other expenses as determined by the club. The increased educational tracks offered at the 2020 Kiwanis International Convention meet the requirements of educational expenses allowed to be deducted from a club's service account. If a club chooses, a fair practice could be to provide two-thirds of any reimbursement from the community

service account and one-third from the administrative account for a member attending all three days.

Expenses related to a member attending only the Kiwanis Annual Meeting would not qualify for any reimbursement from the community service account by Kiwanis standards. Clubs may continue to cover any portion of members' convention expenses from their administrative account

International Kiwanis Convention 3-Day Value Package

Thursday, Friday & Saturday, June 18-20

The value package includes entrance to the Kiwanis Education Conference and two sessions of the Kiwanis Annual Meeting. You'll have access to all keynote speaker sessions and all non-ticketed events. You can also enter the Kiwanis World Showcase, enjoy lunch all three days and party at Thursday's "Kiwanis Night at Victory Field." This package does NOT include Wednesday's Pre-Convention Education Conference sessions. (see below).

He is one of five running for the position. If we send someone to International Convention, we need to get them registered as delegate so they can support Bert. Only approved delegates may vote in Kiwanis International elections and on proposed amendments and resolutions. Kiwanis clubs in good standing are allowed two representatives in the House of Delegates, along with two alternates who may serve if one or both delegates cannot attend.
