A presentation was made to recognize Pete for his forty years of coaching girls' softball with Boulder Valley Girls Softball Association (BVGSA). In 2009, Pete was one of two softball coaches in the USA who were recognized with the Liberty Mutual Responsible Coaching Award for his exemplary dedication and commitment to responsibility in youth sports. --A motion was made and approved that the Happy Dollars collected at each meeting would be transferred to General Fund.

-- A motion was made and approved that background checks for member's participation in K-club related activities be paid for by the Foundation.

GENERAL BUSINESS: Discussion was held and motion made and passed regarding the breakfast fees for members and non-members as follows:
