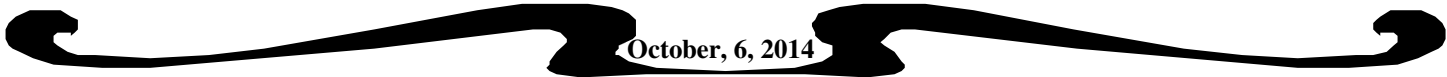

## Snippets from Recent Club Programs

### September 22 - Dr. Brad Birzer, Chair of Conservative Thought & Policy at CU

Dr. Birzer informed us that he has been at CU for three months in his current one year position. He follows Steve Haywood who wrote a book on Reagan. Brad taught previously for 16 years at Hillsdale College in Southern Michigan. Hillsdale was formed in 1844 as an abolitionist college, the first college to give liberal art degrees to women and blacks. It was the first American college to prohibit in its charter any discrimination based on race, religion, or sex, and became an early force for the abolition of slavery. He explained that his position at CU is not political; the position is conservator position – used to discuss what should be taught in our schools. He asks the basic questions: how do we conserve the best and does Socrates and Cisero still have relevance? Brad mentioned that he loves community service clubs. He told us that when President Harding came to office he cut the budget by 69%; he believed in servant leadership and suggested that service clubs be planted in every town to keep communities and politics growing.



### September 29 – Forty-Fifth Annual Installation of Officers and Directors

We heard greetings and remarks from our 2013-14 Lt. Governor, Dawn White. She described a new Kiwanis Club program called 3-2-1: 3 hours of service, 2 hours of social activity, and a 1-hour meeting each month. Clubs should reflect their communities and their members and should work to meet their needs. Flexibility is key to a successful 3-2-1club. The clubs will meet in homes. There is a new club forming this week in Longmont with 15 new charter members. There are also Computer-on-Line Clubs who communicate via webinar and then meet to complete club projects together. She challenged us that our CKI Club is out of model and suggested that we meet with the new Lt. Governor of CKI, Austin Good. The Key Leader Program needs 22 students to attend the Windy Peak Leadership Program in Bailey, CO; we should give her names.. She was glad to hear that the Monarch Key Club is up and operating for the year. The Broomfield Kiwanis Club has folded; their Key Club at Broomfield High needs a sponsor. She suggests that we speak to Kelly about getting a sponsor for the club. (continued on next page).

The Board of the Foothills Kiwanis Foundation met at the Egg and I Restaurant on October 2, 2014. President Pauluhn called the meeting to order at 7:35. Attending were: President Pauluhn, Treasurer Gilland, Secretary Hubbard, Creasey, DeYoung, McMullen, Rogers, Sprenkle and Symes.

SECRETARY'S REPORT: A motion was made and seconded the September minutes be approved. Report approved.

TREASURER'S REPORT: A motion was made and seconded the September Foundation Treasurer's report be approved. Passed.

NEW BUSINESS: McMullen suggested the Club apply for two grants. She will apply for a \$2,500 Kiwanis District grant before December 1 and a grant from Kiwanis International by November 15, amount to be determined. Both grants are for the Dog Project for children. A motion was made and approved to apply for the grants.

--Gilland reported that the service dog in training, Bandit, has exhibited unacceptable passive/ aggressive behavior on several occasions and is no longer acceptable as a project dog.

--McMullen reported the Twisted Pine fundraiser is scheduled for October 18 from 2-6. Twisted Pine will contribute 10% of the day's proceeds to the Dog Project. In addition, there will be a silent auction.

--The 2014-2015 Foundation budget was discussed and approved as amended. An additional \$1,500 was added for the Circle K project.

--DeYoung gave a report on the invested funds with Higgins and Young Investments. The funds had a 4.98% annual return. This is a conservative investment program and a motion was made to approve the continuation of the Foundation investments in this manner. The transfer of BOA money to an FTC account was recommended and approved.

--A motion was made and approved for the \$1,000 donation to the Sweet Dreams in A Bag project immediately.

The Kiwanis Foundation Board Meeting adjourned at 8:13.
