## Snippets from Recent Club Programs

### 9/9/19 – Brian Coleman, on the Boy Scout Jamboree and Drones

Brian, a member of our club, is from Indiana and works for his family business, Magnaproducts – a distributor of magnetic materials worldwide. Recently he attended the 24<sup>th</sup> World Jamboree for Boy Scouts in West Virginia; the world event is held every four years. There were 51,000 scouts, leaders, and support personnel in attendance. The event site was a reclaimed coal mine. Brian went early to help set up the event – they built the city of tents to accommodate all in four days. The Jamboree duration was 12 days. There were 9,000 people on staff – they served 27,000 meals per day in a large tent. During the event Brian and his team provided a drone educational activity the included accurately mapping 2,500 acres of the 10,000 acre site using a Lidar sensor. All the data points were stored for future use. Thanks, Brian, for all that you do to help the Boy Scouts!



### 9/16/19 – Bill Reich, History of Marshall

Bill Reich was raised in Arvada and later graduated in Mechanical Engineering from the University of Colorado. He has written 5 books from his various interests, such as the ice industry and smelting. During the 1859 gold rush, Joseph Marshall from Minnesota knew that these miners would be in need of tools for their work. In 1869 he built a furnace using iron rock from Marshall. His first two furnaces blew out in 1864 and 1865. 200 tons of pig iron were produced in Marshall by running the furnace 24/7. Iron beds were eventually depleted because coal mining was more profitable. Marshall built a cast iron cannon that was fired when Colorado gained statehood. Marshall's partner was Augustus Langford. Bill shared many images of the area around Marshall as drawn by artists and as the area appears today. He collaborated with Beth Simmons, PhD, a geologist who shares his interest in the Marshall story. Ferdinand Hayden, a geologist who came to Marshall in 1877, was hired by the government to determine the best locations for building railroads toward the Pacific. During his stay in the area Hayden spent the night at the home of Joseph Marshall. Thanks, Bill, for interesting program!

### **Treasurer's Report**

Joe Girard reported that as of 9/4, we had made \$212 from our long-term investments. Expenses included a \$1000 donation to Young Life, and an \$1100 to the Rocky Mountain District. \$1000 went to Pack Away Hunger, and \$500 was approved for Habitat. The loan from the Service Dog Foundation has been repaid. Our Scholarship Fund still has \$2500 left in it. All Scholarships must be applied for. The Treasurers Report was unanimously accepted.

### **Alert Dog Treasurer's Report**

Joe reported that we made \$350 from long term investments. \$3434 were deposited in our account from Coolest Dog Website, however, \$6200 had been raised so far according to the website. There were \$40 of copying expenses spent so far. The Alert Dog Treasurer's report was unanimously accepted.

### **Projects Status**

Pack Away Hunger-had 68 participants and packed over 18,000 meals.

Alert Dogs Elway and Cal need retesting. Both due to graduate in November. The poodle's status is currently up in the air. The Kiwanis Magazine wants to do an article around our Alert Dogs' Program.

Alan Teague from Great American Beer contacted Alan Boeve about the cost of printing the cans picturing the winners in the Cool Dog competition. It would require a special run and cost about \$20 per case. The special run would be for approximately 56 gallons. By Oct 5th, 25 cases of beer would be available for the winning families.

Paul Bailey reported that K thru 8 Stars of Tomorrow music teachers must have judges picked by Oct. 12 for the Oct 20th event. Upslope working with host event.

Peak to Peak Key Club has about 200 kids interested in joining, but only 100 of those are realistic candidates.

So far there are no response from the Monarch Key Club officers about helping in the Sept 21st Habitat event in North Boulder. We would serve lunch. Steve should reach out to Thrivent for funds from their project assistance program.
